- 1 The "Sweepstakes Period" is from 12:00:01 am Central Time ("CT") April 1, 2018 ("Sweepstakes-Start") to 11:59:59 pm CT March 31, 2019 ("Sweepstakes-End"). There will be four (4) quarterly drawings (the "Drawing Periods"). Non-winning entries from one Drawing Period will not be rolled over to subsequent Drawing Periods.
 - a) The First Drawing Period is for all surveys completed by 11:59:59 pm CT June 30, 2018 ("Quarter-End") and mail-in entries postmarked by June 30, 2018 and received up to seven (7) days later (See "How to Enter", #3, below).
